#### **President's Report 2022**

#### **Treasurer's Report 2022**

Season 2022 saw us start off with providing returning 2021 members a Covid rebate on registration with a combined total of over \$30k. This was the club's way of saying thank to all club members for sticking with us during the difficult Covid period of 2020 and 2021.

After the past 2 seasons we were really looking forward to having the oval back running at its full force. Canteen, BBQ and full capacity Saturday and Sundays. But unfortunately, Mother Nature had other plans. The Eastern field was wiped out for majority of the season and many weekends were canned due to the fields feeling more like a swamp then the lush fields we love. Over the last 12 months, costs across the board have increased and our prices have stayed the same which has impacted our canteen profit.

Despite these challenges the club was able to turn over a profit that will continue in assisting in the club giving back to its members.

The Committee Expenses noted on the P&L is the ongoing costs for MYOB. It costs us \$70 a month for this.

Match fees were separated for registration fees and upfront payment of the former 'match fees'. Registration fees were set at \$215.00 and 'match fees' were \$100.00. Fees were split in MYOB to reflect that. The invoices for match fees are linked to this account.
